 - d. "including" is understood to mean "including without limitation".
 - e. reference to any statutory provision includes any modification or amendment of it.
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

Data collected

Data that is given to us by you

Data that is collected automatically

This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
 - a. internal record keeping.
 - b. improvement of our products / services.

in each case, in accordance with this privacy policy.

10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

Who we share Data with

- 11. We may share your Data with the following groups of people for the following reasons:
 - a. our employees, agents and/or professional advisors to establish validity of the individual to ensure that the enquiry is genuine.
 - b. relevant authorities o facilitate the detection of crime or the collection of taxes or duties or legislative breaches.

Keeping Data secure

- 12. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a username that is unique to you.
 - b. we store your Data on secure servers.

Data retention

- 16. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

- 17. You have the following rights in relation to your Data:
 - a. **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update, or delete such information. If we provide you with access to the information, we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
 - c. **Right to erase** the right to request that we delete or remove your Data from our systems.
 - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
 - e. **Right to data portability** the right to request that we move, copy, or transfer your Data.
 - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.
